federal entity [NOT a federal employer or federal employee], is taxable as income under Title

Please refer to a communication of July 19, 2005, acknowledged as received by the Fresno IRS on 7-27-05, a copy of which is enclosed regarding your attempt to increase certain "taxable" amounts, referencing 6331(a), which clearly states that 6331(b) and (c) clearly apply only to federal entities, not to private sector people; but which the IRS commonly attempts to intimidate private sector people into believing you have that authority, which is prima facie evidence of
