This letter is in response to the letter you sent to me dated July 11, 2005 (See attached copy) that I received on July 13, regarding the delay in processing of my lawful refund for the tax year 2004.

I strongly disagree with you "changing" my submitted Illinois 1040 Tax Return, reflecting a "zero" on Line 17! (Illinois Withholding)

I strictly followed Illinois Law by using the adjusted income from my federal 1040! My federal 1040 was sent on April 15, 2005 to the IRS Center in Kansas City, MO, for processing and I received my full refund from my submitted return on Tuesday, June 7, 2005! (See attached copy of refund check)

I am attaching the following copies for your review:

- Your letter I received on July 13, 2005
- My federal 1040
- IRS form 4852
- Federal refund check!

Since Illinois has an information sharing arrangement with the Internal Revenue Service, I am compelled to share the substitute W-2 (form 4852) with the State of Illinois. I received nothing of what the Federal Internal Revenue Statutes define as wages for the taxable year 2004, nor did I engage in any trade or business with the Federal Government, except for the interest gained from deposits held in a national bank. They totally agree my affidavit of this fact with evidence of my full refund from the Federal Government!

Given your request in your letter for "Need Withholding Support", the copies of the documents mentioned above that are attached with this letter, should fulfill this request and allow you to complete the refund process.

At this time I am requesting the Illinois Department of Revenue to expedite my request for my full refund of \$ 463.88!
