Please find attached a copy of my 2002 Form 1040X along with the reply I received from Austin. Please note the similarities between the Form 4852 for my 2002 return and the Form 4852 for 2006. Also note that this return was filed in 2005 and was processed and the CP21B was sent to me a little over two months later. The examiner at Austin agreed with my filing.

There is also attached a spreadsheet entitled "Refunds Issued From Kansas City IRS". These refunds can be found on www.losthorizons.com at the locations indicated. Therefore, in compliance with the principal of consistency, I expect the same treatment for my 2006 return as was received by my 2002 1040X as well as all the other people listed on the spreadsheet.
